### CONDITIONS of using a clubs Moorings.

If allocated a mooring I agree to the following conditions:-

1. To lay risers and buoys in the place allocated and to a standard approved by the moorings subcommittee within six weeks of allocation.
2. To pay the appropriate mooring fee on the moorings allocation night each year.
3. To attend work parties as notified on the club website, handbook and club notice board,
4. I hereby authorise responsible persons from the PCC to move my boat if this becomes necessary and to indemnify the PCC against any damage so caused.
5. To vacate the mooring if I cease to be a member of PCC and not to attempt to transfer the mooring under any circumstances.
6. To insure my boat with minimum third party insurance of £1,000,000, including cover to raise the boat should it sink on the clubs premises/moorings and supply a copy of the insurance to the PCC moorings officer at the moorings allocation night and on it's renewal date to the moorings officer during the mooring year.

Should I not comply with all of the following:-

- the insurance cover required on the due date (moorings allocation night and renewal date) and
- renew my club membership on the due date (1<sup>st</sup> January each year) and
- pay for the mooring fee on the due date (moorings allocation night),

I hereby authorise, indemnify and request the PCC to remove my boat from their premises.

7. To maintain the boat in a clean and shipshape fashion.
